

What is a charter school?

- A charter school is a public school!
 - Not geographically bound
 - No tuition for students
 - Not permitted to establish admission policies or limit student admissions any differently than a traditional public school.
 - High level of accountability must meet not only state and federal requirements, but those of their charter authorizer, as well.
 - Must comply with laws pertaining to open enrollment, special education, the unified accounting system, student health and safety, compulsory school attendance, and standardized testing.

Who is LCIS?

- Domestic, Non-profit corporation; Incorporated with the State of Indiana March 3, 2020
- •Section 501(c)(3) federally tax exempt, non-profit organization effective March 2, 2020 (received August 7, 2020)
- •A charter school (grades K-8) located in rural Lawrence county, Indiana

Our Vision



Why LCIS?

- There is an educational need
 - Many area students scored beneath state average in proficiencies of ELA, Science, Social Studies, and Math according to IDOE
- Space & class size concerns
 - Class size maximum = 25 students
 - Emphasis on staff-to-family connection
- We offer a CHOICE
 - Increased competition to traditional public school
 - Focus/Emphasis on special needs students
 - Not bound by district or geographical lines

Core Curriculum and Teaching Model



Basic Learning Environment

- Classroom learning, with average of 25 students per class
- Emphasis on parental involvement
- Emphasis on enhancing critical thinking, reading, oral and written communication, and math and technology skills
- Foster partnerships with area business and industry
- Belief that every student has special talents and abilities; our job to maximize their fullest potential

eLearning Program

- Parents and students will be provided training and assistance
 - LCIS will utilize Google's Education products
 - LCIS Teachers will be required to be Google Certified Level One
- eLearning days will be built into the school calendar and used in cases of school closures (including weather and unforeseen circumstance)

A 'Typical' School Day/year at LCIS

- 180 full-days of instruction
- •State minimum of 5 hour day LCIS will have 7 hour school days (That's 360 additional hours of instruction!)
 - 90-minute blocks of reading and math
 - Two 60-minute sessions of Art, Music, and PE per week
 - 60 minutes Social Studies & Health and Wellness
 - Foreign language activities
 - 60 minutes of extracurricular activities

Revenue & Expense – Prior to Start

EXPENSES

School Funding (LOCAL)



School Funding (STATE) – Based on Enrollment

FOUNDATION FUNDING: \$5,703 per pupil

COMPLEXITY GRANT: \$3,675

x0.1632

\$ 600

Foundation Funding: \$5,703

Complexity Grant: +\$ 600

TOTAL PER PUPIL FUNDING: \$6,303

School Funding (STATE) – Based on Enrollment

SPECIAL EDUCATION FUNDING

Mild and Moderate Disability: $$2300 \times (267 \times 21\%) = $127,733$

Communication Disorders: $$500 \times (((267 \times 21\%) / 3) \times 2) = $18,512$

TOTAL: \$146,245

School Funding (STATE) – Based on Enrollment

CHARTER AND INNOVATION NETWORK SCHOOL GRANT (STATE)

Charter and Innovation Network School Grant:

 $$750 \times 267 = $200,250$

Quick Summary – State Funding

Assuming initial enrollment of 267 students:

Per Pupil Funding: (\$5,703 + 600) * 267 = \$ 1,682,901

Special Education Funding: \$146,245

Charter and Innovation Network Grant: \$200,250

Total State Funding: \$2,029,396 or \$7,600 per pupil



Federal Funding

Part B – Individuals with Disabilities Act (IDEA)

- Reimbursable; for additional associated costs of providing education to students with special needs.
- Variables include: number of special need students enrolled, total school population, and poverty factors.

Title I Funding

Requirement of a minimum of 40% students to be low-income (NLCS reports ~52%)

Title II Funding

 Increase student academic achievement through recruitment and training of quality teachers and principals.
